## **EQUIPMENT:**

Equipment and systems covered by this Certificate are as follows:

SW-HHP-ATEX is a handheld piece of equipment used to control the Loadcell RLP - ATEX. The equipment is powered from two, series connected, Energiser Ultimate Lithium cells. The equipment consists of a radio module PCB and an additional PCB consisting of the safety critical components which are fully encapsulated. It also contains the antenna PCB which is partially encapsulated. The enclosure is made of ABS material which is placed in a rubber casing made of anti-electrostatic material. It consists of an LCD and keypad which is covered by a keypad membrane. All of the exposed parts of the upper casing are coated with anti-electrostatic material. There are no external connections from the equipment.

## **SPECIFIC CONDITIONS OF USE: YES as shown below:**

1. The antistatic coating on the labels can be adversely affected by contact with solvents. Suitable precaution shall be taken to avoid such instances and the labels shall be inspected periodically for any damage.
2. Only Energizer Ultimate Lithium Cells Type L91 AA, certificate number Baseefa14ATEX0107U shall be fitted.
